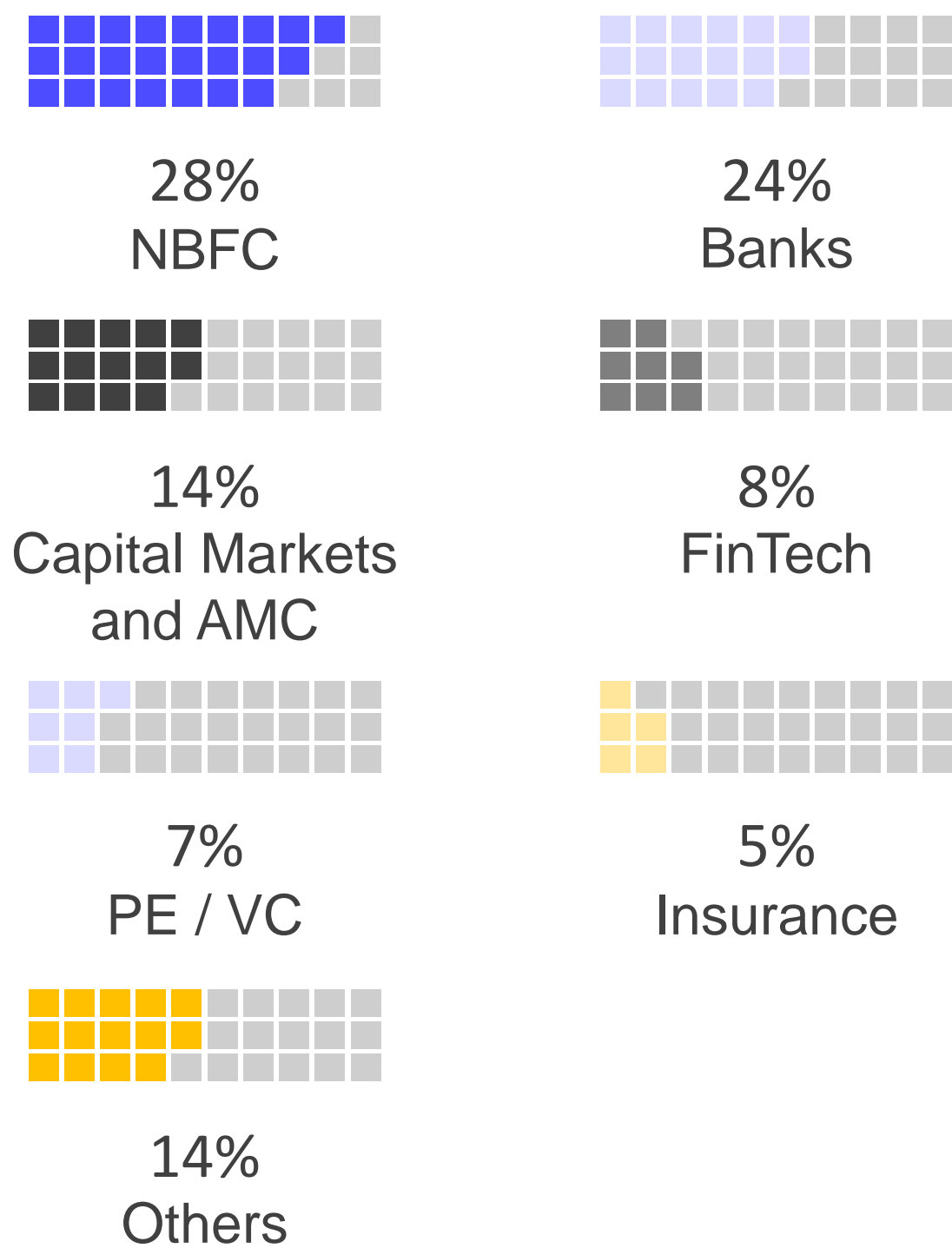

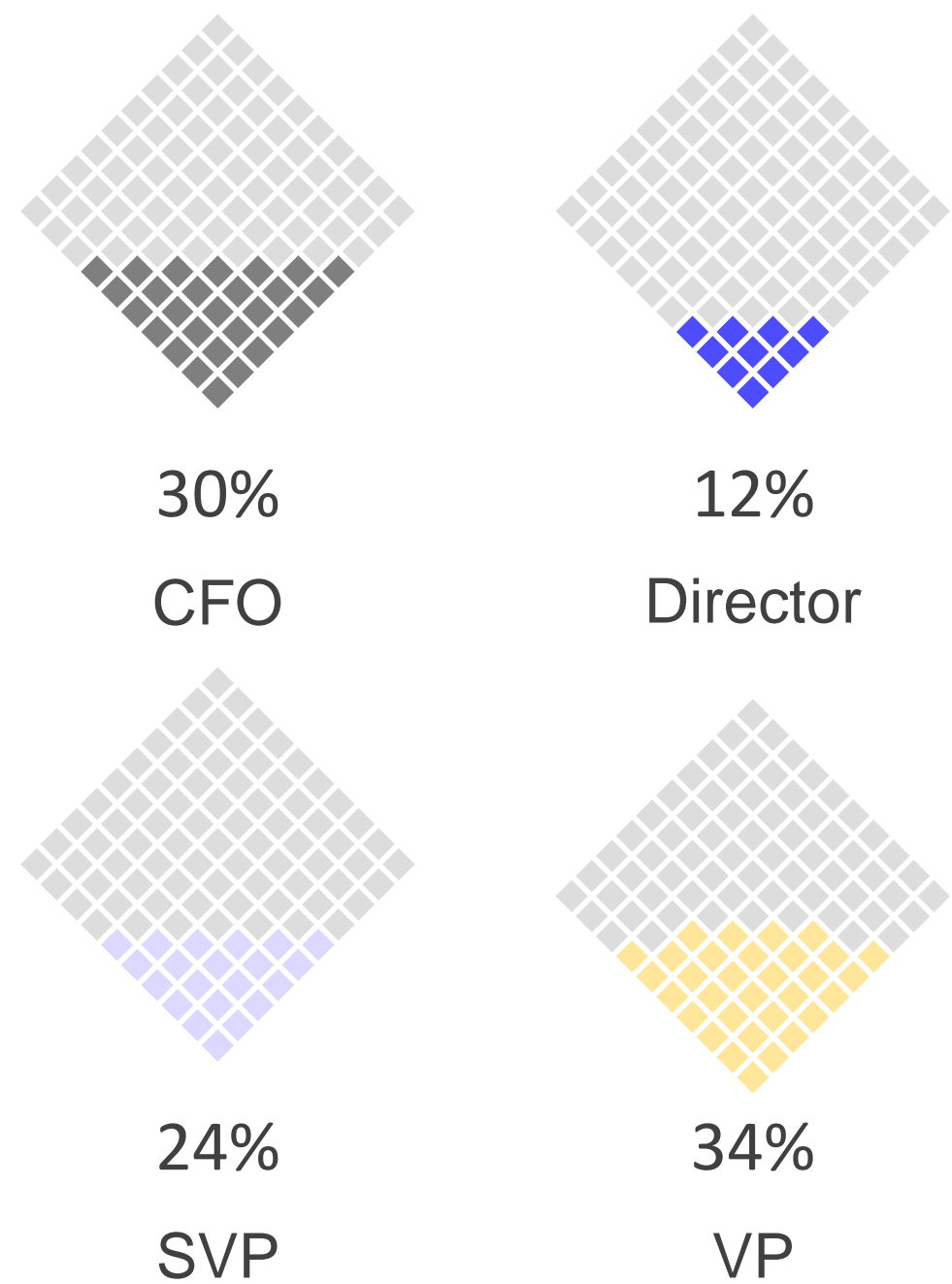

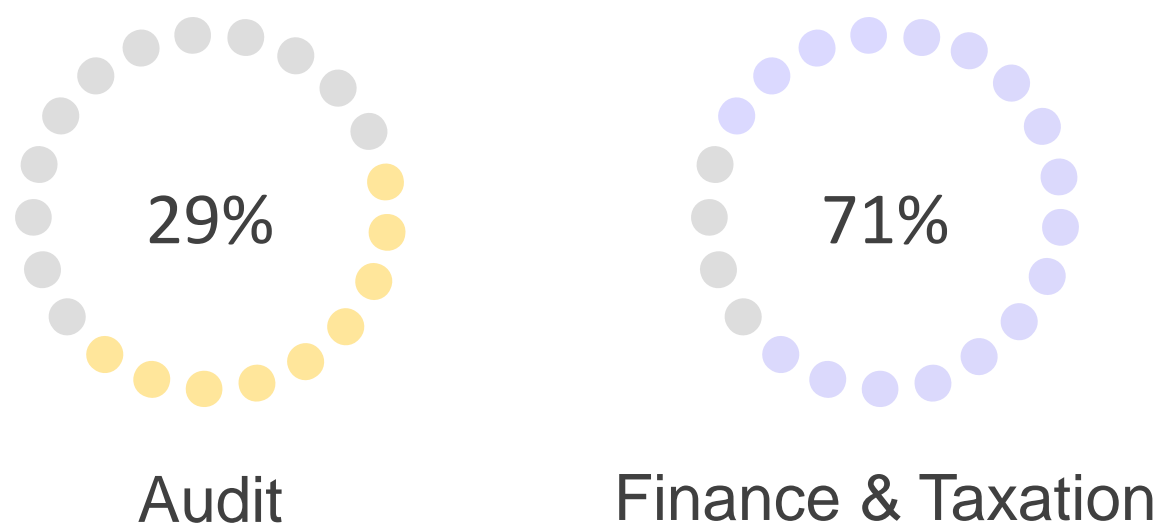
Level wise

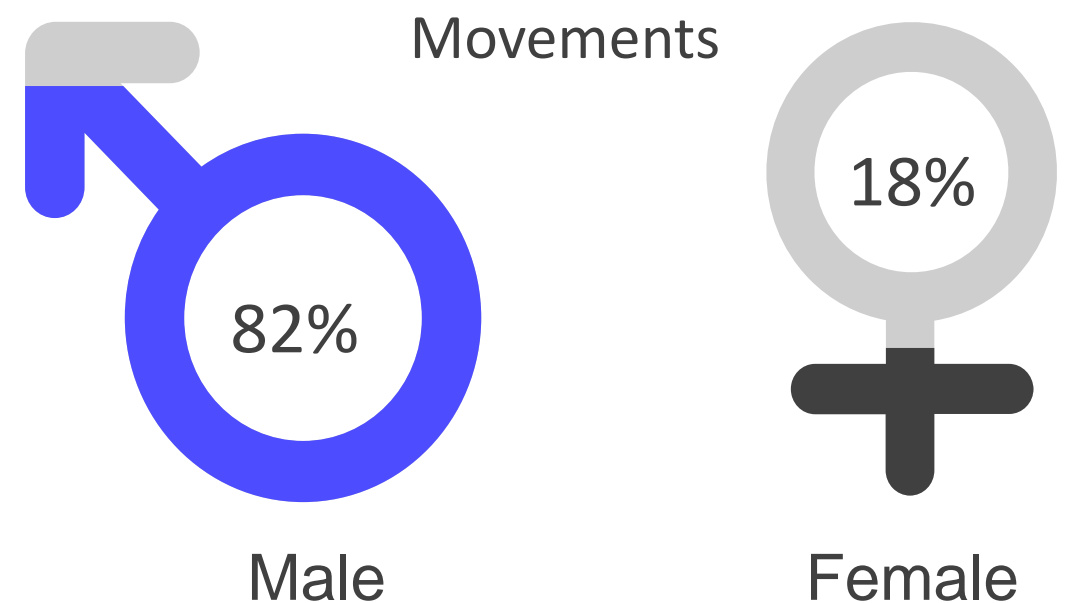
